**Corporate membership of EFNCP**

EFNCP is grateful for the interest you have shown in our work over the years, whether simply by subscribing to *La Cañada*, by participating in one of our seminars or conferences or of course by supporting us financially.

As you may be aware, the Forum is run on a very small budget, with no permanent employees or offices. Nevertheless, we do have a number of core activities over and above individual projects like the biennial conference or our series of occasional seminars in Brussels. These include the production of *La Cañada*, attendance at DG Agriculture Advisory Groups and other meetings to represent EFNCP and basic administration and financial control. Financing these activities and combining them with time-consuming work on projects is becoming an ever-increasing burden on the Forum's directors. That means we not only welcome any practical help we receive but have to be mindful of the expectations of potential funders, hence this letter.

In practice a network of similarly minded organisations and individuals, the Forum is legally a company limited by guarantee under English law. Its members are any legal or natural person who agrees to contribute the sum of £1, *if requested*, to cover the company's debt in the event of it being wound up. The members are entitled to attend the Annual General Meeting, to consider the annual report of the Executive Committee and the financial accounts, to elect the Executive Committee and to appoint the Accountants, in accordance with the Memorandum and Articles which govern the company.

In every application we make to the Commission for support, one of the criteria on which we are judged is the breadth of our network. I am therefore writing to you to ask if, rather than just subscribing to *La Cañada*, your organisation is willing to take on the very limited responsibilities of formal membership of EFNCP.
